REPAIRS + MAINTENANCE ITEMS PROGRAM FOR YOUR LEASED CAR

Let us help you with repairs and items generally considered maintenance by your manufacturer.

Day One Coverage

Wear & Tear Covered

Trip Interruption – We will reimburse you for up to three days of meals and lodging at \$100 per day should your vehicle break down more than 150 miles from your residence.

Rental Reimbursement – We will reimburse you up to \$30 per 24-hour period, up to 5 days, for your rental car.

Transferable – Your vehicle service contract can be transferred should you decide to sell the vehicle privately.

Business Use – Limited to cars, trucks, and vans that are not part of a pool or fleet, as used by the owner for: route work; service or repair work; delivery or hauling; agricultural purposes; job site activities; construction trades and eligible vehicles owned by religious/charitable organizations.

COVERAGE

Brake Pad Coverage – Covers the replacement of one (1) set of front and rear brake pads/shoes during the term of the Service Agreement.

Battery Coverage – Covers one (1) battery replacement during the term of the Service Agreement, or the difference between the manufacturer's prorated reimbursement and the total cost of the battery.

Headlamp/Taillamp Coverage – Covers the unlimited replacement of the headlamps/taillamps during the term of the Service Agreement. Sorry, impact damage not covered.

Belts and Hoses Coverage – Covers the replacement of the engine belts and hoses including: vacuum pump belt, serpentine belt, power steering belt, alternator belt, supercharger belt, AIR pump belt, air conditioner belt, water pump belt, heater hose, bypass hose, throttle body hose, upper and lower radiator hoses, air conditioning hose, power steering pressure and return hose, air hose, washer hoses, vacuum hoses, and fuel hoses.

Windshield Wiper Blade Coverage – Covers the replacement of one (1) set of windshield wiper blades and/or inserts during the term of the Service Agreement.

Electrical Coverage – Unlimited coverage of fuses, interior and exterior light bulbs including: turn signal bulbs, engine compartment lights, running lights, fog lights, stop lights, backup lights, license plate lights, parking lights, trunk light, dome light, courtesy light, visor light, map light and glove box light during the term of the Service Agreement.

Wheel Alignment Coverage – Covers one (1) wheel alignment during the term of the Service Agreement.

Fluid Coverage – We will pay for replacement of necessary fluids, oils, greases, lubricants and approved A/C gases that must be replaced in conjunction with a covered repair.

Green Vehicle Coverage – Covers the replacement of the Hybrid Drive Battery, Electric Drive Battery, or High Voltage Battery in the event of a failure. A professionally installed Charging Station will be repaired in the event of a failure. Coverage will apply to all of the internal components of the Charging Station, except all wiring/cables from outlet to station, station to charger adapter, and other items listed in the Service Contract.

INCLUDED IN YOUR COVERAGE

Towing

Any tow to a qualified repair facility within a **150-mile radius**.

Flat Tire Change

If your spare won't work, we'll provide you with transportation to the nearest tire store for repairs.

Emergency Fuel Delivery Service

We'll arrange for a service provider to deliver two (2) gallons of fuel to your covered vehicle. You are responsible for the cost of the fuel at the time of delivery.

Battery Jump Service

We'll arrange for a service provider to assist you and get your vehicle moving again.

Key Lockout Service

We'll send a service provider and pay up to \$100 per occurrence to cover the cost of the locksmith service.

RESERVE CARE PLUS EXCLUSIONARY COVERAGE

An exclusionary policy covering all components on your vehicle except for a short list of items not covered, mostly items considered normal maintenance by the manufacturer, seen below:

Spark/Glow Plugs, Cap and Rotors, Points, PCV Valves, Emission Components, Filters, Fly Wheels, Flex Plates, Clutch Assembly and Hydraulics, Clutch Lining, Pressure Plate, Tire Pressure Monitors/Sensors, Throw-out and Pilot Bearings, Molded Rubber or Rubber like items, Glass Lenses, Wheels, Tires, Trim, Moldings, Bright Metal, Upholstery, Paint, Exhaust System (excluding Cracked or Warped Exhaust Manifold), Brake Rotors and Drums, Batteries (except as described in this Vehicle Service Contract), Carburetor, Adjustments to: Carburetor, Throttle Body Assembly, Ignition, Transmission Bands, Belts (except as described in this Vehicle Service Contract), or Clutch System; Clean Fuel and Cooling Systems, Remove Sludge or Carbon Deposits, Phones, Television/VCR, DVD Players, Satellite Radio and Electronic Device Software.

TERMS AND PROVISIONS

Vehicles with model years current +1 with less than 12,000 miles qualify for the AUL Reserve Care Lease program. These are general coverage descriptions. Please refer to the Service Contract for complete terms and provisions.
